TAKE NOTICE that a **Public Meeting** will be held on **Tuesday, July 27, 2021 at 6:00 p.m.**, in the Municipality of Mississippi Mills to consider a proposed Minor Variance under Section 45 of the *Planning Act*, R.S.O. 1990, Chapter P.13. The Minor Variance application concerns the property, which is known as Part of Lot 4, Concession 3; Parts 1 and 2 of Plan 26R235; Ramsay, Municipality of Mississippi Mills, known municipally as 573 Concession Road 4 (Ramsay Ward).

PURPOSE OF THE APPLICATION

The applicant is requesting permission from the Committee of Adjustment (COA) to extend a legal non-complying side yard setback for an existing single detached dwelling to support a building addition in the Rural (RU) Zone, from 1.49 m (5' 7/8") to 0.87 m (4'-5 7/8").
