Purpose of the Application:	The purpose of the application is to reduce the required exterior side yard setback to 2.2 m from 4.1 m. The required 4.1 m exterior side yard setback was established through a minor variance in 2020 (A-04-20) to permit the construction of a pharmacy. The requested exterior side yard setback of 2.2 m is the result of a measurement error on the original minor variance application. No change to the original building plans from 2020 is proposed.
