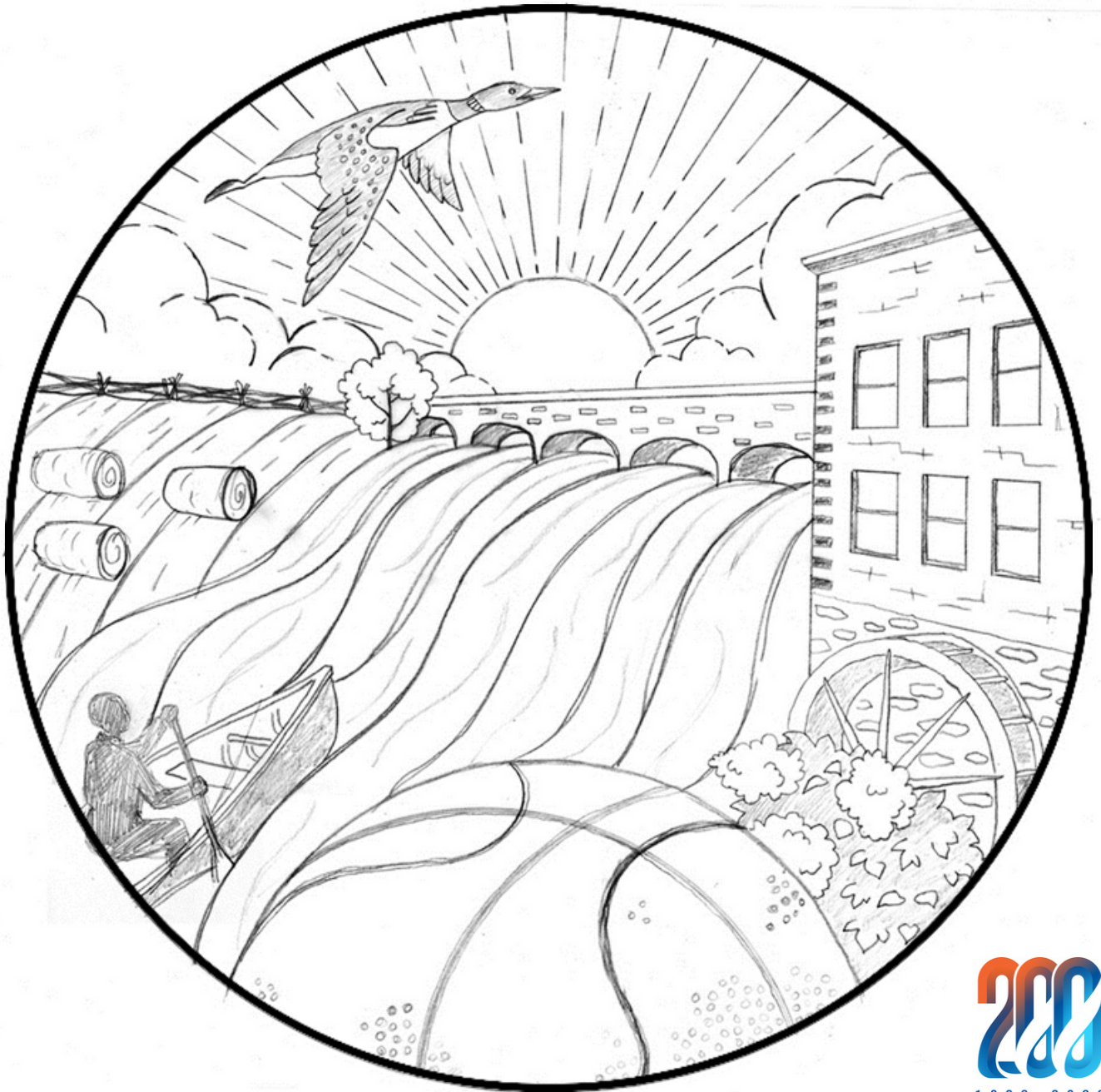

## **Bicentennial Colouring Contest Rules**

The Municipality of Mississippi Mills is offering this contest and is referred to as the "Contest Organizers". By participating in this contest, the person or child's legal parent/guardian is agreeing to the Contest Rules and Terms and Conditions as outlined below.

### **Contest Dates**

The Colouring Contest begins February 1st, 2023 and closes at 5pm on February 23rd, 2023.

### **Eligibility**

Contest open students in grade 4, 5 and 6. One (1) entry per person.

### **Here's How to Enter:**

Print out the page, and colour it in however you like.  
Coloured entries can be dropped off at the Library (Almonte or Pakenham) as well as Almonte Old Town Hall or the municipal office at 3131 Old Perth Rd.
- b) Pick up a copy at your school (if available).

By entering the contest, you agree to let the Contest Organizers post your artwork on Facebook and Instagram (your personal information will be anonymized) and you accept the terms and conditions of the contest.

Be sure to include the following information with your entry: name and age, plus a parent or guardian's phone number, or e-mail address so that winners may be notified.

### **Judging**

Entries will be judged at contest end, and prizes will be awarded at that time. Decisions are at the discretion of the Municipality of Mississippi Mills and are subject to change at any time. We reserve the right to award multiple winners and prizes, or no winners and prizes.

### **Winners & Prizes**

Winners will be notified by email, or phone. The winner will receive a Bicentennial Commemorative Coin and stickers will be made out of the winning entry.

### **General Terms & Conditions**

By entering the Contest, all entrants agree to be bound by the rules of the contest and release the Contest Organizers and all parties associated with this Contest from any liability with respect to the contest and the redemption of any Prize. Contest Organizers reserve the right to withhold the Prize or disqualify any Contestant's entry in the event that any Contestant fail or refuse to comply with these contest rules.
