


# Mississippi Mills 2048 Our Community, Our Future











### The Demographic Forces Driving Growth:

- Provincial governments.

Growth is heavily driven by demographic factors such as birthrates, life expectancy and migration. Demographic changes happen both naturally and as a result of policy decisions made by the Federal and

#### **Natural Demographic Changes:**

People in our Municipality have children and growing families! When young people grow up and want to stay in our Municipality, they also need places to live!

#### **People Moving From Other Places in Ontario and From Other Places in Canada:**

Our Municipality is an attractive place to live! More people from bigger cities like Ottawa are moving to places like Mississippi Mills.



### The Province's Role in Planning For Growth:

- Municipalities in Ontario are created by the Province; this means that Provincial Governments have a big say in how municipalities are run and how they grow.
- Ontario has a planning framework that is driven by Provincial policies. There is a "hierarchy" of planning documents that spell out how planning and growth happen; this "hierarchy" affects all levels of planning from the Province, to the counties and municipality, all the way down to each individual property.
- The Province uses data to predict how the population will grow; they share this data with counties and municipalities
- The Province has directed municipalities to plan ahead in order to accommodate population growth 25 years into the future.

### The County's Role in Planning For Growth:

- Lanark County is the upper tier government for our area; because they are higher up on the chain, their policies and decisions regarding growth affect our growth locally.
- The Province requires that Lanark County adopt a county official plan that provides a vision for future growth and guides the physical development and use of land over the long-term.
- Lanark County adopted the Sustainable Communities **Official Plan (SCOP) which sets settlement area** boundaries for municipalities in the County and allocates a share of the County's projected growth to each municipality.
- Lanark County is currently working on new population projections and a new Growth Management Strategy based on the required 25-year timeframe (to 2048) that will lead to an updated SCOP with new policy directives for the Municipality of Mississippi Mills to follow.

Growth can happen in a number of ways; it can be through expansions to the settlement area boundaries for Almonte, through "as of right" intensification, or through changes in our local policies about density and growth management.

Changes to the way we grow happen through amendments to our local official plan, the Community Official Plan (COP). While changes to the COP are being proposed, the changes that are a part of the Mississippi Mills 2048 project right now are not
