

KEY DATES FOR THE 2018 MUNICIPAL ELECTIONS

<p>May 1, 2018 to July 27, 2018</p>	<p>Nomination Period</p> <p>Nomination forms may be filed by candidates prior to Nomination Day, at any time when the Clerk's Office is open (Monday to Friday 8:30 a.m. to 4:30 p.m.). On Nomination Day, July 27, 2018, nomination forms may be filed 9:00 a.m. to 2:00 p.m.</p>
<p>May 1, 2018 to October 22, 2018</p>	<p>Campaign Period</p> <p>The campaign period begins once a candidate has filed a nomination form and ends on October 22, 2018. Alternative time periods will be in effect if the candidate withdraws the nomination, the Clerk rejects the nomination, or the candidate extends his/her campaign and is continuing to campaign to erase a deficit.</p> <p>The Clerk provides candidates with preliminary maximum campaign expense limit.</p>
<p>NEW May 1, 2018 to October 19, 2018</p>	<p>Third Party Advertising</p> <p>Individuals, corporations or trade unions may file with the Clerk to be a registered third party for the election; in prescribed form. Restrictions apply as to who may register. (MEA 88.6)</p>
<p>April to June 2018</p>	<p>Enumeration</p> <p>A mail-in enumeration will be conducted by the Municipal Property Assessment Corporation (MPAC).</p>
<p>NEW July 27, 2018</p>	<p>Nomination Day</p> <p>The last day for filing nominations. Nomination forms filed on this date may only be filed between the hours of 9:00 a.m. to 2:00 p.m.</p> <p>Third Party Advertising</p> <p>Filings for registration accepted July 27 to October 19, 2018.</p>

July 30, 2018	<p>Certification of Nomination Forms and Acclamations</p> <p>The Clerk shall certify filed nomination forms before 4:00 p.m. Immediately after 4:00 p.m. the Clerk shall declare any acclaimed eligible candidates to be duly elected.</p>
September 4, 2018	<p>Voters' List</p> <p>The Clerk shall make the list of voters available for election purposes only. <i>Note: Public viewing of the Voters' List will be supervised in order to protect personal information.</i></p>
September 4, 2018 to October 22, 2018	<p>Voters' List Revisions – Period for Addition/Correction of Own Name and/or Removal of Deceased Persons from Voters' List</p> <p>An individual may make a written application to the Clerk requesting that their name be added or corrected on the Voters' List or a deceased person's name be removed from the Voters' List. The application must be approved by the Clerk or his/her designate.</p>
September 25, 2018	<p>Certificate of Maximum Campaign Spending Limits to Candidates and Third Party Advertising Registrants</p> <p>The Clerk shall issue the certificate of maximum campaign spending limits to all certified candidates and Third Party Advertising Registrants.</p>
October 15 – 22, 2018	<p>Advance Voting Dates & Location</p> <p>Monday, October 15, 2018 at 8:30 a.m. through to Voting Day on Monday, October 22, 2018 until 8:00 p.m.</p>
October 22, 2018	<p>Voting Day</p> <p>Voting locations are open from 8:30 a.m. to 8:00 p.m.</p>
October 23, 2018	<p>Declaration of Results</p> <p>The Clerk will declare the results of the election of candidates.</p>

December 4, 2018	New Term of Office Commences – Inaugural Council Meeting The elected members shall take the declaration of office prior to taking his or her seat. The term of office commences once the declaration of office has been taken.
December 31, 2018	Campaign Period Ends Deadline for candidate to provide the Clerk with written notification of deficit and continuation of campaign period. This also applies to third party advertisers.
March 29, 2019	Filing Date Deadline for filing financial statements; 2:00 p.m. Penalties for non-compliance may apply.
